HAMPSTEAD SCHOOL ACCEPTABLE USE POLICY 2026-2027

At Hampstead School, we believe that technology can be a powerful tool to enhance learning, enabling students to access information and collaborate with others across the school, community, and the internet. We believe all students, staff, guardian (s), and parent (s) must be good digital citizens by following standards of acceptable use when using personal or school-owned technology.

All students must have a current Technology User Agreement signed and in place prior to being allowed access to the school network. This declaration is an additional document that outlines the standards of acceptable use for students using a personal or school device. Once signed, it will act as an agreement between Hampstead School, EMSB and the student/parent/guardian.

The Hampstead School Code of Conduct and the EMSB Information and Technologies Access and Acceptable Use policy apply to everyone.

General

- The devices used on Hampstead School premises are intended and should be used as pedagogical tools for supporting a student's success in their school work.
- The teachers and school administrator will monitor (as needed) user activity, examine files, etc., on the devices, (i.e., students/parents should not have an expectation of privacy with respect to files, emails, and other activities on the devices) to ensure that the student use of the devices is respecting the restrictions.

Student Declaration

Please take this opportunity to have a conversation with your child about the empowerment of technology use and responsibilities, so that together we can continue to give your children the necessary essential skills when using technology as part of their everyday life.

As a student of Hampstead, I value having access to technology to support my learning. I know that along with this privilege comes great responsibility. To demonstrate my commitment and understanding of the level of responsibility required, I have initialed each of the expectations and guidelines listed on the next page. (Note: Each item must be initialed by the student and his/her parent/guardian to show that together they have reviewed each item and that the student will abide by the rules and expectations laid out for technology use.)

This declaration must be reviewed and signed by both the student and their parent/guardian in order for students to use any electronic devices at school.

Students found to be in violation of the Usage Agreement or the appropriate use policies of the English Montreal School Board will be subject to disciplinary measures. Any disciplinary measures which must be taken with respect to this acceptable use policy will follow the Hampstead School Code of Conduct and the stated policies of the English Montreal School Board.

		I will remain connected to the school wireless network with a device, and will NOT connect to any other (external) wireless network, even though other networks from the neighbourhood might be visible within the school.
		I will use electronic devices in class or school activities only with a teacher's permission and for appropriate purposes, including, internet access, pictures, audio, and video recording.
		I will not install any unauthorized software on EMSB devices at school or at home (for example, downloading apps such as Roblox, Messenger, or other programs).
		I agree to treat all computers and digital equipment with respect and will not damage them by accident or on purpose. In the event of damage, I understand that I may be held responsible for the cost of repairs, depending on the situation.
		I understand that I have several electronic resources available to me that have been provided by the school board including, iWork, GSuite Education apps.
		I may use online communication and collaboration tools such as GSuite Education apps, etc. I will use them appropriately for learning purposes. <i><u>I will not use any types of social media communication or messaging services during school hours</u></i> such as (Facebook, Twitter, Snapchat, Instagram, etc).
		I will <u>not</u> communicate with my parent(s)/guardian(s) or others using messaging services/apps during the school day.
		I understand that I cannot install a personal Apple ID or password on a <u>shared school device</u> . A School Apple ID will be assigned to each student.

Some definitions:

Careful, responsible, and appropriate usage of technology is decided by Hampstead School's administration and teachers.

The interpretation of these terms is guided by the Hampstead School Code of Conduct.

Student Declaration
